Unanimous vote aye. Employee would receive an \$.85/hr probation increase following six mos of employment. Motion by Yackley, second by Shepherd to increase Custodian starting pay to \$18/hr for full time employee with full benefits plus \$.85/hr increase following six mos of employment. Unanimous vote aye.
