INVITATION TO BID

Notice is hereby given that FIRM sealed bids for the complete construction of two separate projects: **1. Milling and Asphalt Overlay in Agar, SD** and **2. Full Depth Reclamation, Cement Treated Subgrade, and Asphalt Surfacing near Onida, SD** will be received by the Sully County Board of Commissioners, Onida, South Dakota at the office of **Sully County Commission Meeting**, 700 Ash Avenue, Onida, South Dakota, 57564 until 9:00 A.M., local time on **Tuesday, November 26, 2024**, and then each publicly opened and read aloud.

The projects consist of: 1. Milling and asphalt concrete overlay of an existing paved roadway in Agar.
2. FDR, Cement Treated Subgrade, & Asphalt Surfacing near Onida.

The complete set of Contract Documents, including drawings and specifications for each project, is on file with the Owner at the Sully County Auditor's Office and the office of Brosz Engineering, 3030 Airport Road, Suite A, Pierre, South Dakota 57501.

Digital Contract Documents are also available from QuestCDN and can be accessed from the Brosz Engineering website at www.broszeng.com under the "Bid Info" page, **Quest #9408310 (Agar) & Quest #9408306 (Onida)**. The cost for downloaded (electronic) plans is \$22 for each project. The official Plan Holders lists can be viewed for the project on the QuestCDN website. Only electronic plan holders downloaded via QuestCDN will receive addendum notifications. Contractors using any other means for obtaining plans and specifications must periodically check the QuestCDN website for any addenda.

Each bid must contain a certified check, a Cashier's check or Draft, for five percent (5%) of the amount of the bid; such check to be certified or issued by either a State or National Bank and payable to the Sully County or in lieu thereof a Bid Bond for Ten percent (10%) of the amount of this bid, such bond to be issued by a Surety authorized to do business in the State of South Dakota and payable to the Sully County as a guarantee that such bidder will enter into a contract with said Sully County, it's Sully County Board of Commissioners thereof in accordance with the terms of such letting and bid in case such bidder is awarded the contract. The Certified Check, or other guarantee, or bid bond of the successful bidder will be returned to him forthwith upon the execution of the contract and surety hereafter provided for.

At the time the successful bidder enters into a contract for the construction of public improvement or the furnishing of any material or labor thereof, the Contractor will be required, before commencing such work, to furnish surety in an amount not less than the contract price, for the faithful performance of such contract, with additional obligation that such performance of such contractor will promptly pay all persons supplying him with labor or material in the prosecution of the work provided for in such contract. The Contractor shall also provide proof of liability insurance and workman's compensation insurance, as per Article 5 of the General Conditions. Two separate contracts will be awarded, one for each project. Contractors can bid on either project or both projects as they deem fit.

The Sully County Board of Commissioners reserves the right to reject any or all Bids and waive any defects therein.
